

“BIG SCREEN SCORE” Football Score Prediction
CONTEST RULES

1. ELIGIBILITY / PROGRAM DESCRIPTION:

No purchase necessary to play. Open to all residents of Maryland, Virginia and Washington, DC who are **21 years of age or older** on the date of entry; excluding employees (including their family and household members) of ESPN 980, Red Zebra Broadcasting, The Big Screen Store and any other agents or companies involved in this Promotion.

2. ESPN 980 Radio is the Sponsor of the “Big Screen Score Contest” Football Score Prediction Promotion. The Promotion begins on Tuesday, September 15, 2009 and ends at 12:00PM on Friday, January 1, 2010, or there have been a total of three (3) Grand Prize winners, whichever occurs first. From all entries received each week, one (1) will be randomly selected at 12:00pm on the Friday prior to the game as the finalist for that week’s contest. Only this finalist’s entry selected will be eligible for prize claims. Sponsor and their respective subsidiaries and affiliates are not responsible for lost, late, misdirected, or illegible entries, or other errors of any kind, whether human, mechanical or electronic. No copies, facsimiles or mechanical reproductions will be accepted. If the finalist’s entry does not match the actual final score of that week’s game, the finalist will be awarded a \$250 gift certificate to The Big Screen Store from ESPN 980 radio.
